IV. Officer Reports

- A. Board Meeting Report (Beth)
 - There were recommendations given about options for the turf field.
 - ii. Information was presented and recommendations were made on the Rain Garden.
 - iii. There were first and second readings of many policies.
 - iv. There was an approval of the Curriculum Committee's recommendation for 5th-9th grade science curriculum.

- B. Executive Director's Update (Dr. Williams)
 - i. The Gender Inclusion Policy Work Group presented recommendations to the Board on how the policy could be practically implemented.
 - a. The scope of the recommendations is expensive.
 - b. The Board will consider and respond with what is within budget to implement.
 - ii. Members of the Nova community will attend the Saint Paul City Council meeting this week to show concern regarding the proposed apartment building on the lot next to Nova.
 - iii. A representative from the Friends of Education came to speak to the staff about a new charter law.
 - a. The language has changed to state that the primary goal of a charter school is to improve all student learning and achievement.
 - b. The charter school authorizer will look at individual students to make sure they are showing growth.
 - c. The direct implications for Nova include how we staff and how to help all children learn and succeed.
 - i. Nova is currently meeting these standards and will continue to strive to do so.
 - iv. The Read 180 Program has shown success at Nova by accelerating learning for struggling readers.

C. Development Committee (Liza)

- i. The SweeTen fundraiser was fantastic and the giving was beyond the \$20,000 goal.
- ii. This will be the last year for the Nova Classic.
 - a. There was discussion about changing it from an official race, which is expensive, to a "Fun Run" that could be sponsored by the track/CC teams.
- D. Upper School Parent Advisory (Jane)
 - i. The Read 180 Program has been successful.

- a. One highlight is that more concepts are reviewed with this method.
- ii. Angela Whited has been planning the Senior Party, which is a post graduation lock-in.

A. Room Parent Events

- i. Staff Appreciation week was April 18th-22nd.
 - a. There were treats, coffee, massages and Pizza Luce.
 - b. It was well-attended and received positive feedback.

 - a. The volunteer sign-up has been sent to the fifth grade parents and will also go out in the Nova Notes mid-May.

- A. NPTO Board Elections for next school year (Sam)
 - i. Kimberly Dumitrica was elected as the Vice Chair.
 - ii. Suzanne Anderson was elected as the Secretary.
 - iii. Dawn Ellerd and Jennifer Bateman-Grover are looking for people to take over their roles for Great Gatherings.
 - a. These people would have their help for two years before fully transitioning into leading this fundraiser.
 - iv. NPTO is looking for new people to take over the Book Fairs.
- B. NPTO Budget for next school year (Liza)
 - i. The NPTO checking account is at \$75,072.87.
 - ii. Liza walked us through the proposed budget for next school year.

- a. The proposed budget for the 2016-17 school year is \$45,000.
- b. There will be an "All School Unplanned" flex fund in the budget.
 - i. This will include money that was in the Background Check expenses as well as a few other expenses.
- c. We need another fundraiser to up our income.
 - i. One idea was to have a Kona Ice fundraiser at Back to School Night where families could buy treats.
- d. Great Gatherings was down \$2,300 this school year.
- e. The budget is heavier on faculty expenses.
 - i. NPTO tries to be fair in distributing between SoG, SoL, SoR, and staff.
 - ii. There was conversation about cutting down the expense of the Faculty Holiday Party.
- C. A motion was approved to move the last NPTO meeting of the school year to May 31st instead of the last day of school, June 7th.
